All TNAs are on track and most of them significantly overachieving their goals.

 \rightarrow A1/2015-09-22: The numbers for *e*-Merlin will submitted in the following week. The deliverable will be submitted too.

The submission of a deliverable does not exclude the remaining extra access hours to be claimed in the PR3. The observations can go on until the end of the project (= 31.12.2015).

Effelsberg is still short on deliverables, but expects to meet the obligations by early December 2015.

LOFAR: →A2 /2015-09-22: A. Polatidis will submit the deliverable.

IRAM: →A3 /2015-09-22: N. Billot will submit the deliverable end of October 2015.

EVN: B. Campbell confirmed that Ventspils stated to be ready for observation in autumn.

→A4 /2015-09-22: B. Campbell will contact the EVN scheduler. It is important that VENTSPILS participates in minimum one experiment, in order to be claim the TNA access cost in RadioNet3.

I. Rottmann informed that for Torun the cost for observation hour is lower (40€) as expected. Therefore, there will be budget remaining.

2. TNA travel budget

To assure a smooth running of the final project accounting, the invoices should be submitted the latest end of October 2015. If TNA leaders know about later expected claims, they should inform A. van den Poll. We have to assure budget reliability to know, how much could be spent for PC meetings.

The TNA leaders agreed on funding the TNA face-to-face meeting (5.11.2015 in Brussels) out of the TNA travel budget, if the user support is assured.

If fitting in the allocation plan of the TNA travel budget for PC meeting use, IRAM could have funded a PC meeting, which is dedicated to RN4 issues. The latest decision on the TNA travel budget distribution is attached.

3. Project status

Questionnaires & publications: The high number of reported users, hours and projects, is inconsistent with the low number of submitted questionnaires and publications.

Sep 22, 2015 TNA - Minutes

On a visit to the new project officer, A. Zensus and I. Rottmann understood that the EC last week made a statistic on the questionnaires. It seems evident, that the statistics will be used for evaluating something. It is unclear if the statistic is for the entire project or individual TNA. To stress the importance of the questionnaires and publications, I. Rottmann and A. Zensus with an email will call upon the TNA leaders and directors. The management should be continuously updated about these issues, not only in the end of the periods/project.
